


REVENUE


PROFIT BEFORE INTEREST, TAX, DEPRECIATION AND AMORTISATION ("EBITDA")


EQUITY ATTRIBUTABLE TO ORDINARY EQUITY HOLDERS OF THE COMPANY

CHAIRMAN'S STATEMENT

On behalf of the board of Directors (the "Board") of Kam Hing International Limited (the "Company", together with its subsidiaries, collectively the "Group"), I am pleased to present to shareholders the annual results for the year ended 31 December 2016 (the "Year").

In 2016, the global economy was surrounded by tense political climate, which restrained consumer sentiment. The United Kingdom's referendum to leave the European Union ("Brexit") and the United States (the "U.S.") presidential election heightened the uncertainties. Along with the subdued economic recovery in European Union countries and continuous slow-down in China economy, global consumers were hesitant about the future economic growth, thereby holding back from spending throughout the Year.

Against such difficult business environment, I am pleased to report a satisfactory net profit attributable to ordinary equity holders of HK\$75.0 million and the Board has resolved to recommend the payment of final dividend of HK1.5 cents per share, subject to approval by the shareholders at the forthcoming annual meeting of the Company.

In times of immense challenges during the Year, we adhered to our commitment to provide reliable and swift delivery of quality products to global customers. Flexible pricing strategies were adopted to maintain production efficiency and market presence. We also relentlessly enhance our capability of offering integrated fabric solutions by expanding the production capacity of our printing facilities in the Enping Plant and acquiring 廣州市番禺東涌工業污水處理有限公司, a set of sophisticated sewage treatment facilities with a sewage license. These long term investments would surely advance our competitive edges to obtain greater market share together with our commitment on our core business during the rough times of economy.



CHAIRMAN'S STATEMENT

While the textile supply has been diminishing in China over the past years, the tightened environmental protection requirements accelerated the market consolidation during the Year. With a number of production factories being forced to shut down, certain customers turned to us with sizable orders starting in the last quarter of 2016. We believe that our endeavours in building ourselves as a quality integrated fabric solutions provider over the years will allow us to benefit from the consolidation, particularly in such unfavourable external circumstances.

We also tactically outreached new customers in different end-markets such as Europe, Korea, Taiwan and ASEAN countries, with the aim to grasp every valuable growth opportunity and mitigate political uncertainties, as well as regional risks.

PROSPECTS

Looking ahead in 2017, it is expected that political issues will dominate the global economy, as well as the international trade. In particular, eyes are on the new U.S. president-elect Mr. Donald Trump's international trade policy and his attitudes towards globalisation. His protectionist economic proposals such as imposing border tax on imported goods may add unpredictability on international trade. On the other hand, the economies of the United Kingdom and the European Union are expected to remain uncertain after the Brexit vote. International Monetary Fund predicted a slower recovery in the euro area due to growing political risks, while China's economy is expected to maintain steady growth.

Despite the uncertainties, we believe that crisis creates opportunities. We are confident to embrace the immense challenges ahead, leveraging on our established reputation and leading position in the textile industry, as well as proven operating capabilities and diversified clientele, to keep on exploring every market opportunity and seek continuous breakthroughs in the global textile supply chain.

APPRECIATION

Finally, on behalf of the Board, I would like to express my sincere gratitude to our management and staff for their performance over the Year, as their contribution was the key to the Group's success. I would also like to take this opportunity to cordially thank all shareholders, investors, customers, suppliers and business partners for their support and assistance.

MANAGEMENT DISCUSSION AND ANALYSIS

MARKET REVIEW

Reviewing the global market in 2016, political uncertainties in advanced economies dominated the world's sentiment, in particular the United Kingdom's decision to leave the European Union and Mr. Donald Trump's victory in the U.S. presidential election. The turbulence somehow hindered the global consumers' behaviour in 2016.

During the Year, the U.S. remained as the Group's major ultimate market and had been going through a fragile economic recovery. While the average unemployment rate of the U.S. decreased from 5.3% in 2015 to 4.9% in 2016, the labour participation rate in December remained stagnate at 62.7% as compared with the previous year, indicating that the labour market was still not recovered yet. Meanwhile, consumers' sentiment made a downturn in the second half of 2016 due to the anticipation of interest rate increase in year end and the bruising U.S. presidential election. According to the studies conducted by the University of Michigan, the index of consumer sentiment dropped from 91.2 in September to 87.2 in October, the lowest level since October 2014; yet, it jumped to 98.2 in December, reaching a 13-year peak with the post-election surge in optimism. This represented another classic in the unpredictable 2016.

Business always thrives on stability and sentiment; enterprises continued to be threatened by the global uncertainties in 2016. Against the backdrop of weak consumer sentiment, the Group observed that the retailers in the U.S. prolonged their seasonal sale period throughout the year, in order to avoid piling stocks, keep inventory lean and hence mitigate risks. This led to another difficult year for the textile export industry in China. As one of the leading textile manufacturers, the Group was inevitably affected. Nonetheless, with accumulated years of experience, the Group was able to persist with tenacity and sustain the core position in the industry.

BUSINESS OVERVIEW

During the Year, the Group's overall revenue decreased by 11.8% to HK\$3,662.6 million (2015: HK\$4,152.7 million). Gross profit reduced by 20.4% to HK\$507.5 million (2015: HK\$637.8 million) and gross profit margin decreased by 1.5 percentage points to 13.9%. Profit attributable to ordinary equity holders of the Company for the Year increased by 28.6% to HK\$75.0 million (2015: HK\$58.3 million), which was mainly due to a gain on disposal of the Group's former head office of HK\$19.9 million during the Year. The basic earnings per share was HK8.6 cents (2015: HK6.7 cents).

In 2016, the Group's sales volume decreased amid the weak global demand for consumer goods. To ensure a relatively stable order flow, the Group strategically maintained the average selling price of its textile products at a steady level. Yet, the risen raw material costs of cotton yarn nibbled the Group's profitability. Small batches orders with short delivery schedule placed by the increasingly prudent buyers also dampened the Group's operation efficiency and net profit margin.

In China, the market consolidation of the textile supply accelerated during the Year. The China government stringently inspected local textile manufacturers for their compliance with the environmental policy and closed down quite a number of unqualified factories in Yangtze River Delta. Towards the end of the Year, orders received by the Group increased as compared with the same period last year as a result of the reduced market supply. It is expected that the market consolidation will continue in 2017 and offer quality and scale textile manufacturers, like the Group, more new business opportunities.

Meanwhile, in view of the increasingly rigid environmental requirement, the Group acquired 廣州市番禺東涌工業污水處理有限公司 in May 2016 for RMB40.8 million (equivalent to HK\$49.8 million). With the ownership, the Group has a full control over the sewage treatment facilities and its sewage license, which would be a valuable and beneficial investment for its long-term development.

MANAGEMENT DISCUSSION AND ANALYSIS

Carrying on its strategy to be the leading integrated fabric solutions provider, the Group continued to upgrade its production facilities in Enping and Panyu, China (the “Enping Plant” and “Panyu Plant” respectively). The Panyu Plant was mainly responsible for yarn dyeing, fabric knitting, cotton fabric dyeing and processing, while the Enping Plant was mainly responsible for fabric knitting, cotton and functional fabric dyeing and printing solutions. In 2016, the Group expanded the production capacity of its printing facility in the Enping Plant. It commenced trial run in the fourth quarter and increased the production capacity of self-supply knitted fabric. Such enhancements would help the Group to differentiate itself from its competitors in the market consolidation, and support its timely delivery of all-rounded textile solutions to customers worldwide.

PROSPECTS

Looking ahead in 2017, political instability will continue to prevail and influence the global economy. With the uncertainties of President Donald Trump’s international trade policies, the U.S. buyers’ purchase is expected to be prudent in 2017. However, the new monetary policy to be introduced by the U.S. may exert more depreciation pressure on Renminbi, and benefit the Group in its production cost control. While the U.S. will remain as the largest market in the medium term, the Group will continue with its risk management strategy through diversifying the customer base. Over the years, the Group has been actively developing diverse textile products to satisfy the varying customers’ needs among the U.S., Europe and Southeast Asia markets. In 2017, the Group will continue to broaden its client mix and product portfolio.

Foreseeing the soft consumption demand in such a volatile business environment, the Group will closely monitor the changing policies and market demand, whilst increasing its resilience against the instable economy through stringent cost control measures and continuous optimization of its operations. The Group will also cautiously assess all possibilities to expand its operation upstream and downstream in the textile sector amid the fast-going market consolidation, with the aim to equip itself to provide comprehensive textile-related solutions for customers, as well as to cement its role as a fabric solutions provider in the industry.

FINANCIAL REVIEW

Revenue

Overall sales turnover achieved HK\$3,662.6 million, representing a decrease of 11.8% as compared with last year (2015: HK\$4,152.7 million). The decrease was mainly attributable to the decrease in sales orders.

Gross Profit and Gross Profit Margin

Gross profit was HK\$507.5 million, representing a decrease of 20.4% from last year (2015: HK\$637.8 million). Gross profit margin decreased to 13.9% (2015: 15.4%), which was mainly attributable to the fact that customers would not increase the price in line with the growth of raw material price due to weak consumer sentiment.

Other Income and Expenses

Other income of HK\$34.7 million (2015: HK\$28.8 million) mainly comprised HK\$16.6 million (2015: HK\$14.1 million) from sales of excess steam generated by the power plant to nearby facilities in the district, HK\$7.3 million (2015: HK\$7.8 million) from fee on air and ocean freight, HK\$3.9 million (2015: Nil) from income received from sewage treatment provided, and HK\$1.2 million (2015: HK\$2.5 million) from subsidy income from PRC government. The remaining balance was primarily the result of rental income and bank interest income.

Selling and distribution expenses decreased to HK\$115.5 million (2015: HK\$129.1 million), which is consistent with the decrease in sales. Administrative expenses, which included salaries and welfare, depreciation and other related expenses, reduced to HK\$309.7 million (2015: HK\$345.0 million) due to the cost control measures.

MANAGEMENT DISCUSSION AND ANALYSIS

Net Profit and Net Profit Margin

Net profit attributable to ordinary equity holders of the Company for the Year was HK\$75.0 million, representing an increase of 28.6% from last year (2015: HK\$58.3 million). The increase in net profit was mainly due to a gain on disposal of the Group's properties during the Year. Net profit margin increased to 2.0% (2015: 1.5%).

Liquidity and Financial Resources

As at 31 December 2016, the Group's net current assets were HK\$571.5 million (2015: HK\$908.3 million). The decrease in net current assets was mainly due to reclassification of the first repayment of syndicated loan in September 2017 to current liabilities. The Group will constantly review its financial position and maintain a healthy financial position by financing its operations from internally generated resources and long-term bank loans. As at 31 December 2016, the Group had cash and cash equivalents of HK\$475.5 million (2015: HK\$517.6 million). Current ratio was 1.3 times (2015: 1.6 times).

As at 31 December 2016, total bank and other borrowings of the Group were HK\$1,746.4 million (2015: HK\$1,853.8 million). The Group's net debt gearing ratio (i.e. net debts divided by the sum of equity and net debts) was at 53.2% (2015: 51.8%). Net debts comprise all interest-bearing bank and other borrowings, accounts and bills payable, an amount due to an associate and accrued liabilities and other payables less cash and cash equivalents. Sum of equity comprises equity attributable to ordinary equity holders of the Company as stated in the consolidated financial statements.

Debtors' turnover period, inventory turnover period and creditors' turnover period for the Year was 57.1 days (2015: 71.8 days), 128.6 days (2015: 106.8 days) and 73.8 days (2015: 61.8 days) respectively. The decrease in debtors' turnover period was mainly due to better control on accounts receivables. The increase in creditors' turnover period and inventory turnover period were mainly due to increase in procurement in the forth quarter of 2016 for preparing shipment in the first quarter of 2017.

Financing

As at 31 December 2016, the total banking and loan facilities of the Group amounted to HK\$5,565.1 million (2015: HK\$5,551.5 million), of which HK\$1,998.1 million (2015: HK\$2,108.5 million) has been utilised.

As at 31 December 2016, the Group's long-term loans were HK\$902.1 million (2015: HK\$1,148.7 million), comprising syndicated loan and term loans from banks of HK\$897.7 million (2015: HK\$1,137.6 million) and long-term finance lease payable of HK\$4.4 million (2015: HK\$11.1 million).

Dividend

The Board has resolved to recommend the payment of a final dividend of HK1.5 cents (2015: HK1.5 cents) per share for the Year and will be payable to the shareholders whose names appear on the register of members of the Company on 20 June 2017. Subject to the approval of shareholders regarding the payment of the final dividend at the forthcoming annual general meeting of the Company, the proposed final dividend will be paid on or about 4 July 2017.

Capital Structure

The capital structure of the Company is composed of equity and debt.

As at 31 December 2016, there has been no change in the capital structure of the Company. The share capital of the Company comprises only ordinary shares.

MANAGEMENT DISCUSSION AND ANALYSIS

Foreign Exchange Risk and Interest Rate Risk

66.5% (2015: 66.5%) of the Group's sales was denominated in U.S. dollars. The remaining sales were denominated in Hong Kong dollars and Renminbi. The majority of the Group's costs of sales were denominated in U.S. dollars, Hong Kong dollars and Renminbi. The Group is therefore exposed to foreign exchange risk arising from currency exposures, primarily in respect to the Renminbi. The exchange rates of other currencies were relatively stable throughout the Year and immaterial on our cost structure. The management closely monitors the foreign exchange movements and determines the appropriate hedging activities when necessary.

The Group's borrowings were mainly maintained at a floating rate basis. The management will pay attention to the interest rate movement and employed necessary hedging instruments in a prudent and professional manner.

Charge of Group's Assets

As at 31 December 2016, certain items of property, plant and equipment of the Group with an aggregate net book value of HK\$29.5 million (2015: HK\$36.6 million) were under finance leases.

At 31 December 2016, certain of the Group's land and buildings with a net carrying amount of approximately HK\$64.0 million (2015: HK\$67.5 million) were pledged to secure a bank loan of HK\$15.6 million (2015: HK\$21.3 million) granted to the Group. Certain of the Group's buildings with a net carrying amount of approximately HK\$6.6 million (2015: HK\$7.9 million) were pledged to the People's Court, Nansha to sequestrate a parcel of land of the Group in respect of a litigation.

Capital Expenditure

As at 31 December 2016, the Group invested HK\$410.2 million (2015: HK\$401.9 million) in capital expenditure of which 71.6% (2015: 84.1%) was used for the purchase of plant and machinery, 24.7% (2015: 11.6%) was used for the construction of new factory premises, and the remaining was used for the purchase of other property, plant and equipment and prepaid land lease payments.

As at 31 December 2016, the Group had capital commitments of HK\$61.6 million (2015: HK\$57.8 million) in property, plant and equipment. All are funded or will be funded by internal resources and bank loans.

Staff Policy

The Group had 6,130 (2015: 6,385) employees in the PRC and 129 (2015: 165) employees in Hong Kong, Macau, Singapore, Korea and others as at 31 December 2016. Remuneration packages are generally structured by reference to market terms and individual qualification. Salaries and wages are normally reviewed on an annual basis based on performance appraisals and other relevant factors. Discretionary bonuses are offered to the Group's staff depending on their performance and the results of the Group. The Group also participates in various defined contribution plans and insurance schemes in compliance with its statutory obligations under the laws and regulations of various locations worldwide.

The Group operates a defined contribution retirement benefit scheme under the Mandatory Provident Fund Schemes Ordinance as well as medical insurance for all its employees in Hong Kong. The Group also participates in various defined contribution plans and insurance schemes in compliance with its statutory obligations under the laws and regulations of various locations worldwide. Also, the Group is obliged to provide its employees in the PRC with welfare schemes covering various insurance and social benefits. Staff benefits are also provided to the staff working in other countries according to the respective countries' statutory requirements.

The Company maintains a share option scheme, pursuant to which share options may be granted to selected eligible participants, with a view to providing an appropriate incentive package for the growth of the Group.

MANAGEMENT DISCUSSION AND ANALYSIS

Major Customers and Suppliers

For the year ended 31 December 2016, sales to the Group's five largest customers accounted for 20.0% (2015: 21.4%) of total sales and sales to the largest customer included therein accounted for 4.7% (2015: 6.4%).

Purchases from the Group's five largest suppliers accounted for 41.4% (2015: 37.6%) of total purchases and purchases from the largest supplier therein accounted for 11.5% (2015: 12.9%).

None of the Directors, their respective close associates (as defined in the Rules (the "Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange")) or shareholders of the Company (which to the knowledge of the Directors) who own more than five percent, of the issued capital of the Company, had any interest in the Group's five largest customers and/or suppliers during the Year.

Segment Information

For the year ended 31 December 2016, the major end-market is remained as U.S.. By analysis of locations of customers, which are garment factories, by regions, sales to the five largest regions (Singapore, Taiwan, Hong Kong, the PRC (other than Hong Kong and Macau) and Korea) accounted for 82.8% (2015: (Singapore, Taiwan, Hong Kong, the PRC (other than Hong Kong and Macau) and Korea) 79.4%) of total sales of the Group and sales to the largest region (Korea) (2015: Korea) included therein accounted for 23.1% (2015: 19.6%) of the Group.

As at 31 December 2016, the Group's assets located in the fabric operation accounted for 98.1% (2015: 99.8%) of the total assets of the Group. Capital expenditure in the fabric operation during the Year accounted for 87.4% (2015: 100%) of the total capital expenditure of the Group.

Material Acquisition and Disposal

During the Year, the Group acquired a 100% equity interest in 廣州市番禺東涌工業污水處理有限公司 at a cash consideration of RMB40.8 million (equivalent to approximately HK\$49.8 million). 廣州市番禺東涌工業污水處理有限公司 has become subsidiary of the Group in May 2016. Further details of such acquisition were set out in the Company's announcement dated 1 March 2016.

In November 2016, the Group completed the disposal of its former head office to independent third parties with a total cash consideration of HK\$19.9 million. A gain on disposal of HK\$19.9 million was recognised by the Group for the Year. The head office of the Group was relocated to support its expanding business scale. Such disposal did not constitute a notifiable transaction of the Company under the Listing Rules.

Except for the above, there was no other material acquisition and disposal by the Group during the Year.

CORPORATE GOVERNANCE REPORT

CORPORATE GOVERNANCE PRACTICES

The Company is committed to maintaining good corporate governance practices. The Company believes that good corporate governance provides a framework that is essential for effective management, a healthy corporate culture, successful business growth and enhancing shareholders' value. The Company has applied the principles and complied with the Corporate Governance Code (the "Code") as set out in Appendix 14 of the Listing Rules throughout the Year, except for the deviation from code provision A.6.7. Code provision A.6.7 provides that independent non-executive directors and non-executive directors should attend general meetings. Mr. Ho Gilbert Chi Hang, being an independent non-executive Director, was unable to attend the annual general meeting of the Company held on 6 June 2016 due to his other business engagement.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 of the Listing Rules as the code for securities transactions by Directors of the Company. Having made specific enquiry of all Directors, the Directors have confirmed that they have complied with the required standard set out in the Model Code for the year ended 31 December 2016.

BOARD OF DIRECTORS

As at 31 December 2016, the Board comprised nine Directors, including six executive Directors and three independent non-executive Directors. Biographical details of the Directors are set out in the section headed "Profile of Directors and Senior Management" on pages 21 to 23 of the annual report.

The audit committee meetings were held to discuss with the management for the accounting policies, internal control and risk management systems adopted by the Group, as well as to review the interim and annual financial statements of the Group before recommending them to the Board for adoption and approval. In additions, the audit committee had meeting with the external auditors twice. It has also reviewed the Company's compliance with the Code.

The audit committee also made recommendation to the Board on the re-appointment of the external auditor. The Board has not taken a different view from that of the audit committee regarding the selection, appointment, resignation or dismissal of the external auditors.

INTERNAL CONTROL

The Board is responsible for maintaining an adequate internal control system to safeguard shareholder investments and Company assets, and reviewing the effectiveness of the same on an annual basis.

The Group has an independent internal audit department. The independent internal audit department is primarily responsible for carrying out review of the internal control system and risk management process. SHAREHOLDERS' RIGHTS

In accordance with the Article 58 of the Articles of Association of the Company, one or more shareholders of the Company holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Company Secretary, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting, the requisitionists themselves may do so in the same manner, and all reasonable expenses incurred by the requisitionists as a result of the failure of the Board shall be reimbursed to the requisitionists by the Company.

Shareholders may by ordinary resolution elect any person to be a Director of the Company. If a shareholder wishes to nominate a person to be elected as a Director, the following documents must be validly served to the Company at the Company's principal place of business in Hong Kong at 23A, TML Tower, No. 3 Hoi Shing Road, Tsuen Wan, New Territories, Hong Kong: (i) his/her notice of intention to propose a resolution at the general meeting; and (ii) a notice executed by the nominated candidate of his/her willingness to be appointed together with his/her information as required to be disclosed under Rule 13.51(2) of the Listing Rules, within the period commencing on the day after the dispatch of the notice of the general meeting appointed for such election and ending on the date falling seven days after the dispatch of the said notice of the general meeting.

Mr. Ho holds a Bachelor of Commerce Degree and a Bachelor of Laws Degree from the University of Sydney, Australia and is a solicitor admitted in New South Wales, Australia and England and Wales and a solicitor and barrister admitted in the High Court of Australia.

Mr. Ho had been a non-executive director of Renhe Commercial Holdings Company Limited (stock code: 1387) during December 2007 to 27 February 2012, a non-executive director of Capital Environment Holdings Limited (stock code: 3989) during 6 January 2010 to 23 September 2010 and an independent non-executive director of Infinity Development Holdings Limited (stock code: 0640) during March 2010 to 21 November 2013, and is an independent non-executive director of Hailiang International Holdings Limited (stock code: 2336) since 12 May 2014 and Asia Allied Infrastructure Holdings Limited (Stock code: 0711) since 20 January 2017, all of the above-mentioned companies are listed companies in Hong Kong. Mr. Ho joined the Group on 4 May 2010.

NOTES TO FINANCIAL STATEMENTS

31 December 2016

1. CORPORATE AND GROUP INFORMATION

The Company was incorporated as an exempted company with limited liability in the Cayman Islands on 26 November 2003 under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands.

The principal place of business of the Company is located at 23A, TML Tower, No. 3 Hoi Shing Road, Tsuen Wan, New Territories, Hong Kong. The principal activity of the Company is investment holding. Details of the principal activities of the principal subsidiaries are set out in note 43 to the financial statements. There were no significant changes in the nature of the Group's principal activities during the year.

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for an equity investment at fair value through profit or loss and derivative financial instruments which have been measured at fair value. These financial statements are presented in Hong Kong dollars ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2016. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the ordinary equity holders of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to the consolidated statement of profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's interest in an associate is stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's interests in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's interests in associates or joint ventures.

If an interest in an associate becomes an interest in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

The Group measures its derivative financial instruments and equity investment at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, financial assets and deferred tax assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/ amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

Related parties

A party is considered to be related to the Group if:

(a) the party is a person or a close member of that person's family and that person

- (i) has control or joint control over the Group;
- (ii) has significant influence over the Group; or
- (iii) is a member of the key management personnel of the Group or of a parent of the Group;

or

(b) the party is an entity where any of the following conditions applies:

- (i) the entity and the Group are members of the same group;
- (ii) one entity is an associate or joint venture of the other entity (or of a parent, subsidiary or fellow subsidiary of the other entity);
- (iii) the entity and the Group are joint ventures of the same third party;

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. When an item of property, plant and equipment is classified as held for sale or when it is part of a disposal group classified as held for sale, it is not depreciated and is accounted for in accordance with HKFRS 5, as further explained in the accounting policy for “Non-current assets and disposal groups held for sale”. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sale proceeds and the carrying amount of the relevant asset.

Construction in progress represents buildings, plant and machinery and equipment under construction, which is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Non-current assets and disposal groups held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amounts will be recovered principally through a sales transaction rather than through continuing use. For this to be the case, the asset or disposal group must be available for immediate sale in its present condition subject only to terms that are usual and customary for the sale of such assets or disposal groups and its sale must be highly probable. All assets and liabilities of a subsidiary classified as a disposal group are reclassified as held for sale regardless of whether the Group retains a non-controlling interest in its former subsidiary after the sale.

Non-current assets and disposal groups (other than investment properties and financial assets) classified as held for sale are measured at the lower of their carrying amounts and fair values less costs to sell. Property, plant and equipment and intangible assets classified as held for sale are not depreciated or amortised.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

Leased assets

Leases that transfer substantially all the rewards and risks of ownership of assets to the Group, other than legal title, are accounted for as finance leases. At the inception of a finance lease, the cost of the leased asset is capitalised at the present value of the minimum lease payments and recorded together with the obligation, excluding the interest element, to reflect the purchase and financing. Assets held under capitalised finance leases, including prepaid land lease payments under finance leases, are included in property, plant and equipment, and depreciated over the shorter of the lease terms and the estimated useful lives of the assets. Assets acquired through hire purchase contracts of a financing nature are accounted for as finance leases, but are depreciated over their estimated useful lives. The finance costs of such leases are charged to the statement of profit or loss so as to provide a constant periodic rate of charge over the lease terms.

Leases where substantially all the rewards and risks of ownership of assets remain with the lessor are accounted for as operating leases. Where the Group is the lessor, assets leased by the Group under operating leases are included in non-current assets, and rentals receivable under the operating leases are credited to the statement of profit or loss on the straight-line basis over the lease terms. Where the Group is the lessee, rentals payable under operating leases net of any incentives received from the lessor are charged to the statement of profit or loss on the straight-line basis over the lease terms.

Prepaid land lease payments under operating leases are initially stated at cost and subsequently recognised on the straight-line basis over the lease terms.

When the lease payments cannot be allocated reliably between the land and buildings elements, the entire lease payments are included in the cost of the land and buildings as a finance lease in property, plant and equipment.

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as either financial assets at fair value through profit or loss, or loans and receivables, as appropriate. The Group determines the classification of its financial assets at initial recognition. When financial assets are recognised initially, they are measured at fair value plus transaction costs that are attributable to the acquisition of the financial assets, except in the case of financial assets recorded at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss include financial assets held for trading. Financial assets are classified as held for trading if they are acquired for the purpose of sale in the near term. Derivatives are also classified as held for trading unless they are designated as effective hedging instruments as defined by HKAS 39.

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in the statement of profit or loss. These net fair value changes do not include any dividends or interest earned on these financial assets, which are recognised in accordance with the policy set out for "Revenue recognition" below.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial measurement, such assets are subsequently measured at amortised cost using the effective interest rate method less any allowance for impairment. Amortised cost is calculated by taking into account any discount or premium on acquisition and includes fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation and the loss arising from impairment are recognised in the statement of profit or loss.

Impairment of financial assets

The Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or a group of financial assets is impaired. An impairment exists if one or more events that occurred after the initial recognition of the asset have an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated. Evidence of impairment may include indications that a debtor or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation and observable data indicating that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

Financial assets carried at amortised cost

For financial assets carried at amortised cost, the Group first assesses whether impairment exists individually for financial assets that are individually significant, or collectively for financial assets that are not individually significant. If the Group determines that no objective evidence of impairment exists for an individually assessed financial asset, whether significant or not, it includes the asset in a group of financial assets with similar credit risk characteristics and collectively assesses them for impairment. Assets that are individually assessed for impairment and for which an impairment loss is, or continues to be, recognised are not included in a collective assessment of impairment.

The amount of any impairment loss identified is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not yet been incurred). The present value of the estimated future cash flows is discounted at the financial asset's original effective interest rate (i.e., the effective interest rate computed at initial recognition).

The carrying amount of the asset is reduced through the use of an allowance account and the loss is recognised in the statement of profit or loss. Interest income continues to be accrued on the reduced carrying amount using the rate of interest used to discount the future cash flows for the purpose of measuring the impairment loss. Loans and receivables together with any associated allowance are written off when there is no realistic prospect of future recovery and all collateral has been realised or has been transferred to the Group.

If, in a subsequent period, the amount of the estimated impairment loss increases or decreases because of an event occurring after the impairment was recognised, the previously recognised impairment loss is increased or reduced by adjusting the allowance account. If a write-off is later recovered, the recovery is credited to the statement of profit or loss.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, or loans and borrowings, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings, net of directly attributable transaction costs.

The Group's financial liabilities include accounts and bills payables, accrued liabilities and other payables, interest-bearing bank and other borrowings, derivative financial instruments and an amount due to an associate.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities are classified as held for trading if they are acquired for the purpose of repurchasing in the near term. This category includes derivative financial instruments entered into by the Group that are not designated as hedging instruments in hedge relationships as defined by HKAS 39. Gains or losses on liabilities held for trading are recognised in the statement of profit or loss. The net fair value gain or loss recognised in the statement of profit or loss does not include any interest charged on these financial liabilities.

Loans and borrowings

After initial recognition, interest-bearing loans and other borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Derivative financial instruments and hedge accounting

Initial recognition and subsequent measurement

The Group uses derivative financial instruments, such as forward currency contracts, to hedge its foreign currency risk. Such derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently remeasured at fair value. Derivatives are carried as assets when the fair value is positive and as liabilities when the fair value is negative.

Any gains or losses arising from changes in fair value of derivatives are taken directly to the statement of profit or loss, except for the effective portion of cash flow hedges, which is recognised in other comprehensive income and later reclassified to profit or loss when the hedged item affects profit or loss.

Current versus non-current classification

Derivative instruments that are not designated as effective hedging instruments are classified as current or non-current or separated into current and non-current portions based on an assessment of the facts and circumstances (i.e., the underlying contracted cash flows).

- Where the Group expects to hold a derivative as an economic hedge (and does not apply hedge accounting) for a period beyond 12 months after the end of the reporting period, the derivative is classified as non-current (or separated into current and non-current portions) consistently with the classification of the underlying item.
- Embedded derivatives that are not closely related to the host contract are classified consistently with the cash flows of the host contract.
- Derivative instruments that are designated as, and are effective hedging instruments, are classified consistently with the classification of the underlying hedged item. The derivative instruments are separated into current and non-current portions only if a reliable allocation can be made.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short-term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, which are not restricted as to use.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries and an associate, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Income tax (continued)

Deferred tax assets are recognised for all deductible temporary differences, the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries and an associate, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, which it is intended to compensate, are expensed.

Revenue recognition

Revenue is recognised when it is probable that the economic benefits will flow to the Group and when the revenue can be measured reliably, on the following bases:

- (i) from the sale of goods, when the significant risks and rewards of ownership have been transferred to the buyer, provided that the Group maintains neither managerial involvement to the degree usually associated with ownership, nor effective control over the goods sold;
- (ii) from the rendering of services, when the relevant services have been rendered;
- (iii) rental income, on a time proportion basis over the lease terms;
- (iv) interest income, on an accrual basis using the effective interest method by applying the rate that discounts the estimated future cash receipts over the expected life of the financial instrument to the net carrying amount of the financial asset; and
- (v) dividend income, when the shareholders' right to receive payment has been established.

Employee benefits

Share-based payments

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external professionally qualified valuer using the binomial/Black-Scholes option pricing models, further details of which are given in note 28 to the financial statements.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

Share-based payments (continued)

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

Pension schemes and other retirement benefits

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme, in accordance with the rules of the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

Staff benefits are also provided to the staff working in other countries according to the respective countries' statutory requirements.

Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or statement of profit or loss is also recognised in other comprehensive income or statement of profit or loss, respectively).

The functional currencies of certain overseas subsidiaries are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year. The resulting exchange differences are recognised in other comprehensive income and accumulated in a separate component of equity. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

Research and development costs

All research costs are charged to the statement of profit or loss as incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Classification between investment properties and owner-occupied properties

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group.

Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately, the Group accounts for the portions separately. If these portions could not be sold separately or leased out separately under a finance lease, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Otherwise, the property is classified as an owner-occupied property.

Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

Impairment of assets

In determining whether an asset is impaired or the event previously causing the impairment no longer exists, the Group has to exercise judgement in the area of asset impairment, particularly in assessing: (1) whether an event has occurred that may affect the asset value or such event affecting the asset value has not been in existence; (2) whether the carrying value of an asset can be supported by the net present value of future cash flows which are estimated based upon the continued use of the asset or derecognition; and (3) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate. Changing the assumptions selected by management to determine the level of impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test.

Withholding taxes arising from the distributions of dividends

The Group's determination as to whether to accrue for withholding taxes arising from the distributions of dividends from certain subsidiaries according to the relevant tax jurisdictions is subject to judgement on the timing of the payment of the dividend. The Group considered that if the profits will not be distributed in the foreseeable future, then no withholding taxes should be provided.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, which may cause an adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 31 December 2016 was HK\$12,811,000 (2015: Nil). Further details are given in note 15.

Impairment allowance for accounts and bills receivables

The Group makes impairment allowance for accounts and bills receivables based on an assessment of the recoverability of accounts and bills receivables. Allowances are applied to accounts and bills receivables where events or changes in circumstances indicate that the balances may not be collectible. The identification of doubtful debts requires the use of judgement and estimates. Where the expectation is different from the original estimate, such difference will impact the carrying value of accounts and bills receivables and impairment allowance for accounts and bills receivables in the year in which such estimate has been changed.

Impairment of inventories

Management of the Group reviews the inventory ageing analysis on a periodic basis for those aged inventories. This involves comparison of the carrying value of the aged inventory items with the respective fair value less costs to sell. The purpose is to ascertain whether impairment is required to be made in the financial statements for any obsolete and slow-moving items. In addition, physical counts on all inventories are carried out on a periodic basis in order to determine whether impairment needs to be made in respect of any obsolete and defective inventories identified.

4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and services and has two reportable operating segments as follows:

- (a) the fabric products segment engages in the production and sale of knitted fabric and dyed yarn and the provision of related subcontracting services; and
- (b) the "others" segment includes the provision of sewage treatment service, and the provision of air and ocean freight handling services and mining.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resources allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/(loss), which is a measure of adjusted profit/(loss) before tax.

Intersegment revenue and transfers are transacted with reference to the selling prices used for sales made to third parties at the then prevailing market prices.

Pursuant to the PRC Corporate Income Tax Law, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 5% or 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008. At 31 December 2016, no deferred tax has been recognised for withholding taxes that would be payable on the unremitted earnings that are subject to withholding taxes of the Group's subsidiaries established in Mainland China. In the opinion of the directors, it is not probable that these subsidiaries will distribute such earnings in the foreseeable future. The aggregate amount of temporary differences associated with interests in subsidiaries in Mainland China for which deferred tax liabilities have not been recognised totalled approximately HK\$243 million at 31 December 2016 (2015: HK\$246 million).

There are no income tax consequences attaching to the payment of dividends by the Company to its shareholders.

The Group has estimated tax losses arising in Hong Kong of HK\$16,355,000 (2015: HK\$14,686,000) that are available indefinitely for offsetting against future taxable profits of the Company and the respective subsidiaries in which the losses arose. No deferred tax assets have been recognised in respect of these losses as the directors consider it is not probable that future taxable profit will be available against which these tax losses can be utilised.

28. SHARE OPTION SCHEME

The Company operates a share option scheme (the "Scheme") for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Eligible participants of the Scheme include the Company's directors, including independent non-executive directors, other employees of the Group, suppliers of goods or services to the Group, customers of the Group, any consultant, advisor, manager or officer who provides research, development, other technological support or services to the Group, the Company's shareholders, and any non-controlling shareholder of the Company's subsidiaries. The Scheme became effective on 9 June 2014 and unless otherwise cancelled or amended, will remain in force for 10 years commencing from 9 June 2014.

The maximum number of shares which may be allotted and issued upon the exercise of the share options to be granted under the Scheme is 86,991,900 shares, representing 10% of the share capital of the Company as at the date of adoption of the scheme mandate limit and as at 31 December 2016. The maximum number of shares issuable under share options to each eligible participant in the Scheme within any 12-month period, is limited to 1% of the shares of the Company in issue at any time. Any further grant of share options in excess of this limit is subject to shareholders' approval in a general meeting.

Share options granted to a director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the price of the Company's shares at the date of grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

The offer of a grant of share options may be accepted within 21 days from the date of offer, upon payment of a nominal consideration of HK\$1 in total by the grantee. The exercise period of the share options granted is determinable by the directors, and commences after a certain vesting period and ends on a date which is not later than 10 years from the date of offer of the share options or the expiry date of the Scheme, if earlier.

The exercise price of the share options is determinable by the directors, but may not be less than the highest of (i) the nominal value of the Company's shares; (ii) the Stock Exchange closing price of the Company's shares on the date of offer of the share options; and (iii) the average Stock Exchange closing price of the Company's shares for the five trading days immediately preceding the date of offer.

Share options do not confer rights on the holders to dividends or to vote at shareholders' meetings.

During the year, no share options were granted by the Company under the Scheme.

At the date of approval of these financial statements, the Company had no share options outstanding under the Scheme.

29. RESERVES

The amounts of the Group's reserves and the movements therein for the current and prior years are presented in the consolidated statement of changes in equity of the financial statements.

The capital reserve of the Group represents (i) the premium of HK\$93,378,000 arising from the issue of shares by Joint Result Holdings Limited ("Joint Result") for settlement of the amounts due to directors on 31 December 2003; and (ii) the excess of the nominal value of the share capital of the subsidiaries acquired pursuant to the group reorganisation which took place on 24 August 2004, for the Company became the holding company of the companies now comprising the Group (the "Group Reorganisation"), over the nominal value of the 1,000,000 shares of HK\$0.1 each of the Company issued in exchange therefor and the then existing 1,000,000 shares of HK\$0.1 each credited as fully paid at par.

In accordance with the relevant PRC regulations, the subsidiaries which are established in the PRC are required to transfer 10% of their profits after tax, as determined under the PRC accounting regulations, to the statutory surplus reserve, until the balance of the reserve reaches 50% of their respective registered capital. Subject to certain restrictions as set out in the relevant PRC regulations, the statutory surplus reserve may be used to offset against accumulated losses of the respective subsidiaries.

31. BUSINESS COMBINATION

On 1 March 2016, the Group acquired a 100% equity interest in 廣州市番禺東涌工業污水處理有限公司 ("Sewage Treatment Company") from an independent third party (the "Owner") (the "Acquisition"). Sewage Treatment Company owns a sewage treatment plant in Panyu, the PRC (the "Plant") and is principally engaged in provision of sewage treatment service. The Acquisition was completed in May 2016. The purchase consideration of RMB40,801,500 (equivalent to approximately HK\$49,758,000) for the acquisition was settled in the form of cash during the year.

Goodwill of approximately RMB10,505,000 (equivalent to approximately HK\$12,811,000) was recognised upon the completion of the Acquisition. The Group considers that the Sewage Treatment Company would add immediate scale to its other operation in the PRC. None of the goodwill recognised is expected to be deductible for income tax purposes.

According to the agreement, the Group had agreed to enhance the property, plant and equipment of the Plant within the first 10 years of the lease term for an amount of not less than RMB20 million (equivalent to HK\$25 million) (the "Asset Enhancement") (note 34(b)). The Asset Enhancement, being part of the payment by the Group in respect of the Plant Arrangement, was recognised as an expense on a straight-line basis over the lease terms of 20 years. The Group had also undertaken to indemnify the Owner for any shortfall in the net asset value of the Plant by the end of the lease terms (the "Indemnity"). The Group agreed to compensate the Owner for the difference between the net asset value of the Plant at the inception of the lease terms and at the end of the lease terms. In the opinion of the directors, considering the uncertainties surrounding the operation performance of the Plant during the lease term, no reliable estimate could be made on the potential outflow of resources required to settle the obligation on the Indemnity. Accordingly, no provision regarding liabilities arising therefrom had been made by the Group in these financial statements as at 31 December 2015.

38. TRANSFERS OF FINANCIAL ASSETS

Transferred financial assets that are not derecognised in their entirety

At 31 December 2016, the Group endorsed certain bank bills receivable in the PRC (the “Endorsed Bills”) with a carrying amount of RMB4,690,000 (equivalent to HK\$5,299,000) (2015: RMB42,330,000 (equivalent to HK\$51,622,000)) to certain suppliers in order to settle the accounts payable due to such suppliers (the “Endorsement”). In the opinion of the directors, the Group has retained the substantial risk and rewards, which include default risks relating to such Endorsed Bills, and accordingly, it continued to recognise the full carrying amounts of the Endorsed Bills and the associated accounts payable settled. Subsequent to the Endorsement, the Group did not retain any rights on the use of the Endorsed Bills, including the sale, transfer or pledge of the Endorsed Bills to any other third parties. The aggregate carrying amount of accounts payable settled by the Endorsed Bills during the year to which the suppliers have recourse was RMB4,690,000 (equivalent to HK\$5,299,000) (2015: RMB42,330,000 (equivalent to HK\$51,622,000)) as at 31 December 2016.

Transferred financial assets that are derecognised in their entirety

At 31 December 2016, the Group endorsed certain bank bills receivable in the PRC (the “Derecognised Bills”) which were originally endorsed by its customers, to certain of its suppliers for settling the trade payables due to such suppliers with a carrying amount in aggregate of RMB37,761,000 (equivalent to HK\$42,668,000) (2015: RMB12,663,000 (equivalent to HK\$15,443,000)). The Derecognised Bills have a remaining maturity from one to five months (2015: one to five months) at the end of the reporting period. In accordance with the Law of Negotiable Instruments in the PRC, the holders of the Derecognised Bills have a right of recourse against the Group if the PRC banks default (the “Continuing Involvement”). In the opinion of the directors of the Company, the Group has transferred substantially all risks and rewards related to the Derecognised Bills. Accordingly, it has derecognised the full carrying amounts of the Derecognised Bills and the associated trade payables. The maximum exposure to loss from the Group’s Continuing Involvement in the Derecognised Bills and the undiscounted cash flows to repurchase these Derecognised Bills is equal to their carrying amounts. In the opinion of the directors of the Company, the fair values of the Group’s Continuing Involvement in the Derecognised Bills are not significant.

During the years ended 31 December 2016 and 31 December 2015, the Group has not recognised any gain or loss on the date of transfer of the Derecognised Bills. No gains or losses were recognised from the Continuing Involvement, both during the year or cumulatively. The Endorsement has been made evenly throughout the years ended 31 December 2016 and 31 December 2015.

39. FAIR VALUE AND FAIR VALUE HIERARCHY OF FINANCIAL INSTRUMENTS

Management has assessed that the fair values of cash and cash equivalents, pledged deposits, accounts and bills receivables, accounts and bills payables, financial assets included in prepayments, deposits and other receivables, financial liabilities included in accrued liabilities and other payables, and an amount due to an associate approximate to their carrying amounts largely due to the short term maturities of these instruments.

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale. The following methods and assumptions were used to estimate the fair values:

The fair values of the non-current portion of other receivables and interest-bearing bank and other borrowings have been calculated by discounting the expected future cash flows using rates currently available for instruments with similar terms, credit risk and remaining maturities.

40. LITIGATION

Litigation with a previous subcontractor and its affiliated company

On 26 June 2013, a previous subcontractor of the Group (the “Subcontractor Plaintiff”) filed a claim to the PRC Court against the Guangzhou Municipal Land Resources and Housing Administrative Bureau (the “Bureau”) claiming that the Bureau performed invalid verification procedures when issuing a land and building certificate in respect of a parcel of land in Panyu (the “Land”) to the Group. The Land was previously owned by the Subcontractor Plaintiff and acquired by the Group pursuant to a sale and purchase agreement (the “Sale and Purchase Agreement”) entered into during the year ended 31 December 2011. The carrying value of the Land acquired from the Subcontractor Plaintiff and the leasehold improvements attached to the Land as at 31 December 2016 was approximately RMB22.1 million (equivalent to HK\$25 million) (2015: RMB23.5 million (equivalent to HK\$29 million)). The Subcontractor Plaintiff demanded the PRC Court to disregard the invalid verification procedures and cancel the land and building certificate. On 17 September 2013, a court hearing was held at the PRC Court and the PRC Court rejected all demands from the Subcontractor Plaintiff.

On 30 September 2013, the Subcontractor Plaintiff filed an appeal to the Intermediate People’s Court, Guangzhou. On 28 August 2015, the Intermediate People’s Court, Guangzhou ruled in favour of the Subcontractor Plaintiff, and ordered to overtake the PRC Court ruling and cancel the land and building certificate issued by the Bureau to the Group. On 23 September 2015, the Group appealed (the “Appeal”) to the High People’s Court of Guangdong Province (the “High Court”). Moreover, on 21 September 2015, the Group filed a separate claim against Subcontractor Plaintiff to the PRC Court (the “Land Case”), demanding the Subcontractor Plaintiff to honour the Sale and Purchase Agreement to retransfer the title of the Properties (as defined in the paragraph below) to the Group.

On 21 September 2015, the Group applied to the PRC Court to sequester the buildings attached to the Land and the Land (the “Properties”) and provided certain of the buildings held by the Group with net carrying amounts of HK\$6.6 million (2015: HK\$7.9 million) (note 13) to the PRC Court as security. On 19 October 2015, the PRC Court ordered to sequester the Properties from 19 October 2015 to 18 October 2018 (the “Seal”). Based on the legal opinion given by the Group’s PRC legal counsel, the Seal prohibited the Subcontractor Plaintiff from taking further actions which may undermine the legal right of the Group over the Properties, including but not limited to the sale, transfer, lease or pledge of the Properties, or to utilise the Properties to obtain a guarantee from third parties. On 4 November 2015, the PRC Court ordered to hold the hearing of the Land Case on the grounds that the ruling of the Land Case is dependent on the result of another Court case between the Subcontractor Plaintiff and its affiliated company regarding the legitimacy of a board meeting held by the Subcontractor Plaintiff which approved the disposal of the Land to the Group (the “Subcontractor Plaintiff Case”).

Litigation with a previous subcontractor and its affiliated company (continued)

On 1 December 2015, the High Court turned down the Appeal filed by the Group. However, on 21 December 2015, the Intermediate People's Court, Guangzhou, concluded the Subcontractor Plaintiff Case and confirmed that the board approval was a valid approval from the legal perspective. Thereafter, the PRC Court resumed the Land Case and scheduled a hearing to be held on 31 March 2016.

On 31 October 2016, the PRC Court ruled in favour of the Group and ordered the Subcontractor Plaintiff to adhere to the terms stated in the Sale and Purchase Agreement and to retransfer the title of the Properties to the Group.

On 11 November 2016, the Subcontractor Plaintiff filed an appeal to the Intermediate People's Court, Guangzhou. On 2 March 2017, the Intermediate People's Court, Guangzhou, turned down the appeal filed by the Subcontractor Plaintiff and concluded the judgement of the PRC Court on 31 October 2016 as conclusive for the Land Case.

Taking into account the latest ruling granted by the Intermediate People's Court, Guangzhou, on 11 November 2016, the facts and the merits of the legal ground substantiated at the Subcontractor Plaintiff Case, and the opinion given by the Group's PRC legal counsel, the directors of the Company consider that the Group could execute its right to order the Subcontractor Plaintiff to honour the Sale and Purchase Agreement and to retransfer the land and building certificate of the Land to the Group. Accordingly, the Group continued to recognise the Properties at their carrying amounts of RMB22.1 million (equivalent to HK\$25 million) (2015: RMB23.5 million (equivalent to HK\$29 million)) in these financial statements as at 31 December 2016.

41. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments, other than derivatives, comprise interest-bearing bank and other borrowings and cash and short term deposits. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as accounts and bills receivables, other receivables, accounts and bills payables, accrued liabilities and other payables and an amount due to an associate, which arise directly from its operations.

The Group also enters into derivative transactions, including principally forward currency contracts. The purpose is to manage the currency risk arising from the Group's operations and its source of finance.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below. The Group's accounting policies in relation to derivatives are set out in note 2.4 to the financial statements.

Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's interest-bearing bank borrowings with floating interest rates.

The Group regularly reviews and monitors the floating interest rate borrowings in order to manage its interest rate risk. The interest-bearing bank and other borrowings are stated at amortised cost and not revalued on a periodic basis. Floating rate interest income and expenses are credited/charged to the statement of profit or loss as earned/incurred.

The following table demonstrates the sensitivity to a reasonably possible change in interest rates, with all other variables held constant, of the Group's profit before tax (through the impact on floating rate borrowings).

Foreign currency risk

Foreign currency risk is the risk of losses due to adverse movements in foreign exchange rates relating to investments denominated in foreign currencies. The Group has transactional currency exposures. Such exposures arise as a substantial portion of sales and purchase transactions is conducted by the Group's subsidiaries in US\$ and RMB with the counterparties. As the Hong Kong dollar is virtually pegged to US\$, the Group does not expect any significant movements in the US\$/Hong Kong dollar exchange rate in the foreseeable future. In order to minimise the impact of foreign exchange exposure on RMB-denominated transactions, the Group had entered into forward currency contracts with creditworthy banks to manage its exchange rate exposure.

Credit risk

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis.

Since the Group trades only with recognised and creditworthy third parties, there is generally no requirement for collateral.

The credit risk of the Group's other financial assets, which comprise cash and cash equivalents, an equity investment at fair value through profit or loss, and other receivables, arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

The Group's credit risk exposure is spread over a number of counterparties and customers. Hence, it has no significant concentration of credit risk by a single debtor.

Liquidity risk

The Group monitors its risk to a shortage of funds by considering the maturity of both its financial instruments and financial assets (e.g. accounts and bills receivables) and projected cash flows from operations.

The Group's objective is to maintain a balance between continuity of funding and flexibility through the use of bills payable and interest-bearing bank and other borrowings to meet its working capital and capital expenditure requirements.

- * Included in interest-bearing bank and other borrowings are bank loans of HK\$8,750,000 (2015: HK\$33,394,000) and finance lease payables of nil (2015: HK\$1,936,000) containing a repayment on demand clause giving the lender the unconditional right to call the loan at any time and therefore, for the purpose of the above maturity profile, these amounts are classified as “on demand”.

Notwithstanding the above repayment on demand clause, the directors do not believe that the bank loans and finance lease payables will be called in their entirety within 12 months, and they consider that the bank loans and finance lease payables will be repaid in accordance with the maturity dates as set out in the respective agreements. This evaluation was made considering: the financial position of the Group at the date of approval of the financial statements; the Group’s compliance with the loan covenants; the lack of events of default, and the fact that the Group has made all previously scheduled repayments on time. In accordance with the terms of the bank loans and finance lease payables, their maturity terms at 31 December 2016 are HK\$840,643,000 in 2017, HK\$562,913,000 in 2018, HK\$306,725,000 in 2019, HK\$38,976,000 in 2020, HK\$7,822,000 in 2021, and HK\$179,000 in 2022 (2015: HK\$675,122,000 in 2016, HK\$341,375,000 in 2017, HK\$548,330,000 in 2018, HK\$290,346,000 in 2019, HK\$12,520,000 in 2020, and HK\$2,326,000 in 2021).

Capital management

The primary objectives of the Group’s capital management are to safeguard the Group’s ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders’ value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. In order to maintain or adjust the capital structure, the Group may adjust the amount of dividend payment to shareholders, return capital to shareholders or issue new shares. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2016 and 31 December 2015.

The Group monitors capital using a gearing ratio, which is net debt divided by the total capital plus net debt. Net debt comprises all interest-bearing bank and other borrowings, an amount due to an associate, accounts and bills payables, and accrued liabilities and other payables less cash and cash equivalents. The total equity comprises ordinary equity holders’ equity as stated in the consolidated statement of financial position.

On a winding-up, the holders of the non-voting deferred shares are entitled, out of the surplus assets of KH Textile and KH Piece Works, to a return of the capital paid up on the non-voting deferred shares held by them to one half of the balance after a total sum of HK\$100,000,000,000,000 has been distributed in such winding-up in respect of the ordinary shares of KH Textile and KH Piece Works.
- Yingxing is registered as a wholly-foreign-owned enterprise under the PRC law with an operating period of 20 years commencing from 7 September 2010. The registered capital of Yingxing amounted to HK\$30,000,000 and the remaining unpaid capital contribution of HK\$5,000,000 (2015: HK\$5,000,000) was included as commitments at 31 December 2016 as disclosed in note 35 to the financial statements.
- En Ping KH is registered as a wholly-foreign-owned enterprise under the PRC law with an operating period of 20 years commencing from 27 April 2005. The registered capital of En Ping KH amounted to US\$85,000,000, of which US\$75,267,000 (2015: US\$72,859,000) was paid up as at 31 December 2016. The remaining unpaid capital contribution of US\$9,733,000 (2015: US\$12,141,000) (equivalent to approximately HK\$75,435,000 (2015: HK\$94,093,000)) was included as commitments at 31 December 2016 as disclosed in note 35 to the financial statements.

- (d) En Ping KL is registered as a wholly-foreign-owned enterprise under the PRC law with an operating period of 20 years commencing from 8 June 2007. During the year, En Ping KL applied for a reduction of registered capital and the registered capital of En Ping KL was reduced from US\$34,000,000 as at 31 December 2015 to US\$20,000,000 as at 31 December 2016, of which US\$20,000,000 (2015: US\$20,000,000) was paid up as at 31 December 2016. As at 31 December 2015, the remaining unpaid capital contribution of US\$14,000,000 (equivalent to approximately HK\$108,500,000) was included as commitments as disclosed in note 35 to the financial statements. During the year, Kam Wing applied for capital reduction and share capital of Kam Wing was reduced from HK\$107,500,000 as at 31 December 2015 to HK\$100,000 as at 31 December 2016.

During the year ended 31 December 2015, the Group further acquired a 9% interest each in Kam Wing and En Ping KL from non-controlling interests at a total cash consideration of HK\$16,000,000 and the excess of the consideration over the share of net assets acquired from non-controlling interests amounting to HK\$2,733,000 was debited to other reserve and included in the equity.

- (e) Kam Sing is registered as a wholly-foreign-owned enterprise under the PRC law with an operating period of 20 years commencing from 2 January 2004.
- (f) Guangzhou KH is registered as a wholly-foreign-owned enterprise under the PRC law with an operating period of 25 years commencing from 26 March 1992. The registered capital of Guangzhou KH amounted to US\$192,610,000, of which US\$166,371,000 (2015: US\$163,818,000) was paid up as at 31 December 2016. The remaining unpaid capital contribution of US\$26,239,000 (2015: US\$28,792,000) (equivalent to approximately HK\$203,352,000 (2015: HK\$223,138,000)) was included as commitments at 31 December 2016 as disclosed in note 35 to the financial statements.
- (g) KH China is registered as a wholly-foreign-owned enterprise under the PRC law with an operating period of 20 years commencing from 9 October 2013. The registered capital of KH China amounted to US\$10,000,000, of which US\$2,000,000 (2015: US\$2,000,000) was paid up as at 31 December 2016. The remaining unpaid capital contribution of US\$8,000,000 (2015: US\$8,000,000) (equivalent to approximately HK\$62,000,000 (2015: HK\$62,000,000)) was included as commitments at 31 December 2016 as disclosed in note 35 to the financial statements.
- (h) During the year ended 31 December 2015, the Group disposed of certain investment holding and dormant subsidiaries to independent third parties at an aggregate consideration of HK\$15,000. HK\$557,000 of exchange fluctuation reserve was released from the disposal of the subsidiaries and the resulting gain on disposal of subsidiaries of HK\$542,000 was recognised in the consolidated statement of profit or loss during the year ended 31 December 2015.
